SUBMISSION GUIDELINES

Papers: Please ensure your submission adheres to the following format:

- **Title:** Use Times New Roman (TNR) 12 pt, bold, in all capital letters, aligned to the right.
- **Author(s):** Include the name(s) in TNR 12 pt, aligned to the right, two lines below the title. Add a * symbol next to the last name, with the footnote specifying the workplace (separately for each author if applicable).
- **Abstract:** Provide a summary of up to 200 words in TNR 11 pt, italics, justified, two lines below the author's name. Clearly outline the objectives, methodology, main results, and conclusions.
- **Keywords:** Include 4–6 words in TNR 11 pt, italics, justified, listed by importance.
- **JEL Classification Code:** Mention the paper's JEL category/code (e.g., K for law and economics literature).

WORKSHOP PROPOSALS

Panels addressing a specific theme and featuring at least five speakers from different institutions are encouraged. Proposals should include an overview of the panel's objectives and a summary of each participant's contribution.

OUTCOMES AND GOALS

The conference aims to promote interdisciplinary dialogue among academics and practitioners, fostering knowledge exchange and collaboration. We encourage submissions that present analytical insights, case studies, and innovative approaches to the challenges in the announced fields.
